

FENCE PERMIT SUBMITTAL REQUIREMENTS

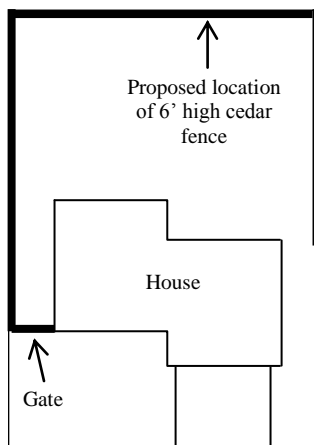
- ⊖ **Application** Submit completed building permit application along with **ALL** supporting documents. Building permit forms are available online or at the City. Fence permit is valid for six (6) months from date of issuance.
- ⊖ **Site Plan** One copy of a *Plat of Survey* or similar site plan is required. A scaled drawing may also be acceptable or use the Milwaukee County GIS system to print a site map: <http://county.milwaukee.gov/mclio>. Be sure to illustrate existing structures, roads, alleys, etc. and the proposed fence location, setbacks, and dimensions. (*Fences are NOT permitted in any floodway area. Additional floodplain restrictions may apply.*)
- ⊖ **Photographs** A drawing, photograph, brochure, or advertisement depicting the fence style is required. **Please Note:** The “good side” or “non-structural” side must face the abutting property(s).
- ⊖ **Signed Waivers** Owner shall collect signed fence waivers from **ALL** abutting property owners and submit along with the permit application. **Fence waiver template is provided on the reverse side of this document.**
- ⊖ **Permit Fee** **Residential Fence Fee: \$105.00** (\$70 permit fee + \$35 plan review fee)
Commercial Fence Fee: \$190.00 (\$140 permit fee + \$50 plan review fee)
(A fence that is 3.5 feet or less in height does NOT require a permit. Fence height is measured from the ground surface to top or highest point of the fence panel.)

Incomplete applications cannot be processed until all information has been received. To avoid delays, please ensure that all required documents are submitted with your application.

General Fence Restrictions:

- Maximum Fence Height: **Residential:** 6 feet (*side & rear yards only*) **Commercial:** 8 feet.
- No fence, other than a decorative or split-rail type is permitted in residential front yards.
