DANCE HALL LICENSE

Section 7.15.3 City of Glendale Code of Ordinances provides that it shall be unlawful to hold any public dance or public ball within the City of Glendale unless the dance hall or tavern premises in which the same may be held shall first be licensed for such purpose.
